# **Certificate of Registration**

The Certificate of Registration is issued by the Charities and Fundraisers Division of the Colorado Secretary of State's office. It enables your organization to legally fundraise in Colorado. Below are links to the Colorado Secretary of State's website related to the registration:

# **Certificate of Good Standing**

The Certificate of Good Standing is issued by the Business Division of the Colorado Secretary of State's office. Organizations (including nonprofit organizations) operating in Colorado are required to have a record on file with the Business Division of the Colorado Secretary of State, and the Certificate of Good Standing is the document issued related to that filing.
